• The management/Authorities have not Produced license copy of remaining buildings in the premises.

The building is owned/occupied by Smt. Pushpa Shamanur Mahalingappa Residential School. The University B.D.T. college of Engineering, Davanagere has been issued fitness certificate for Taksha Shila Block (Only). The building & said premises inspected by the officers of Public Works Department on 22-07-2025 in the presence of Chairman. The said Taksha Shila building is structurally fit for occupancy for running school with effect from 22-07-2025 for a period of 3 (Three) years.

At the time of visual Inspection following observations are made :

- The premises of Smt. Pushpa Shamanur Mahalingappa Residential School consisting of 1) Nalanda Block, 2) Chilipili A-Block, 3) Chilipili B-Block, 4) Amaravathi Block & 5) Taksha Shila Block from North end respectively.
- The Building Safety Certificate is requested by the Trust only for Taksha Shila Block.
- The High voltage Transmission lines passes in between Nalanda Block & Chilipili A-Block which are situated in the same premises where Taksha Shila Block exists.

- The High voltage Transmission lines passes about 7.40 mtr away from North – East corner & 3.40 mtr away from North – West corner at the side of Nalanda Block.
- The another High voltage Transmission lines passes about 5.50 mtr away from South – East corner & 9.80 mtr away from South – West corner at the side of Chilipili A-Block.
- The high tension line is about 63.00 mtrs away from the Taksha Shila block.
- The Building for which stability certificate sought exists at South end of the property that is at the side of Amaravathi Block.
- As per the fitness report given by the University B.D.T. college of Engineering Davanagere, The Taksha Shila building seems satisfactory.
- The High voltage Transmission lines passes through the same premises of these buildings, is required to take necessary permission from KPTCL.
- The management/Authorities have not produced building approved plan, drawings, structural details, licenses and other necessary documents at the time of inspection except Taksha Shila Block.
- The storm water drain passes 5.00 mtrs away on south side of the Taksha Shila building compound. Flows through East to west direction.
- The Structural Safety Certificate is issued only for Taksha Shila Block subject to obtain NOC from KPTCL. If any hazards happen due to High voltage Transmission line, the School/Management/Authority is responsible.
